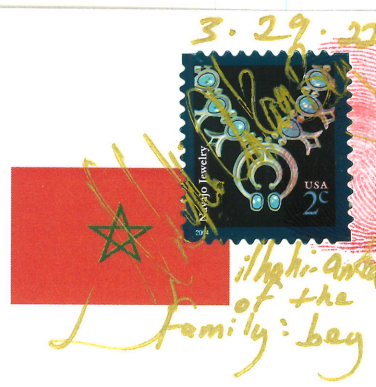

Affidavit of Reversion of Estate Nunc Pro Tunc at North America

On this natural day, I, Ilhahi Ankaa Bey, the living, sentient man and rightful Heir to the North Gate Estate / North America, am not lost at sea; and I Affirm and Declare my permanent Right of 'Reversion of Estate' and therefore I make no claim with respect to any false title and misrepresented (*name / Man-of-Straw and nom de guerre; - being a title*) and the spurious creations of the foreign, *de facto* United States Corporate operators, actors, and mistaken owners via any **STATE OF / State of – COUNTY OF / County of – CITY OF / City of, etc.**, operations at North America – the organic land mass and continent; and I surrender and assign any and all 'Reversionary Interest' to the foreign United States and all of its subsidiaries (including 'Contractors') for full 'Acquittance Discharge Settlement' and 'Closure' of my reliance, **Title 12 USC 95a, part 2**. I assume absolutely no liabilities or debts, however contrived, among any of its associates; and I do not (nor did I ever knowingly and willingly) consent to stand as any 'Surety', for ANY created 'Man-of-Straw' against myself, for the foreign, private, and for-profit, **UNITED STATES INCORPORATED / U. S. Corporation Company** entity owners, directors, assigns, or their administrators via any **STATE OF / State of – COUNTY OF / County of – CITY OF / City of, etc.**; nor do I stand as 'Surety' for any of its subsidiaries or associates at any point, or moment in time. Furthermore, any and all military activities conceived or attempted against this Heir are hereby demanded to 'Cease & Desist' immediately, as all injurious military activities against me, are subject to International Law (*Universal Law*) mandates (including penalties and punishments) for the Republic / People. As an Al Moroccan / American national – *Moor / Muur* – Aboriginal and Indigenous to North America, I assert my birthright for permanent, International Law protections against *genocide*. I hereby invoke the *United Nations Charter Declaration on the Rights of Indigenous Peoples* – 13 September 2007 as preliminary protection (but not limited to). Therefore ALL States, and State subsidiaries operating at North America, through Domestic Police forces (including, but not limited to, said 'Troopers' and said 'Sheriffs') and security agencies (public or private), must adhere to leaving this Heir Apparent in perpetual peace in his life, liberty, and pursuit of happiness.
