INTERNATIONAL PUBLIC NOTICE & PRESS RELEASE

This Legal and Lawful International Public Notice is hereby being permanently placed and served to all individuals, including but not limited to, private citizens, private persons, private employees, public employees, public servants, citizens, diversified citizens, foreign nationals, individuals, dual citizenship persons, commissioners, public servants, residents, offices and their said 'Officials', domestic police force employees, operating as whatever entity came into existence through the State of Florida / STATE OF FLORIDA, while doing business at North America (said 'UNITED STATES' et. al.)

Due to ongoing abuses by the unidentified and withheld identity of the private persons and / or citizens operating via various titles and entities outside of the constitutional fold of government, specifically the 'supreme law of the land' clause contracted only by the constitution for the united States of America Republic (for the natural people to the land as said 'inhabitants'), this notice serves as Public Notice and permanent record to effectuate, indefinitely, the 'supreme law of the land' clause as the supreme contract per the constitution for the united States of America Republic (for the natural people). Such international clause involves treaty obligations in succession to form the constitution for the united States of America Republic. This notice is for securing the birthrights (again) for the aboriginal and indigenous people to the land, the true Americans / Al Moroccans, also known historically as Moors / Muurs, for which malicious persons operating through Cities, Counties, and even States continue to ignore for personal agendas by profiteering endeavors involving racketeering and forced servitude by human trafficking mechanisms conducted throughout the State of Florida / STATE OF FLORIDA, including (but not limited to) ORANGE COUNTY, VOLUSIA COUNTY, BREVARD COUNTY, etc.

The security guard agents continue to make frivolous complaints to CITY OF ORLANDO POLICE DEPARTMENT employees, for which CITY OF ORLANDO POLICE DEPARTMENT employees act fraudulently upon city ordinances, statutes, and / or codes which have nothing to do with the free nationals to the land.
