RE: Color-of-Law Complaint Submission - CITY OF ORLANDO POLICE DEPARTMENT

Dear Kristen Clarke,

I have contacted your office today to make my formal, national complaint concerning the willful negligence of a multitude of employees operating as Public Employees and / or Public Servants via the State of Florida / STATE OF FLORIDA, united States of America / United States of America et. al. My complaint is in direct relation to an already issued Color-of-Law Violations warning to the City of Orlando Public Servant, Buddy Dyer, on October 7, 2021. The warning was in regard to police employees operating upon my land and estate, having trespassed upon my flesh and blood being in the recent past thus depriving myself of my birthrights on my land. In this particular matter, I have been deprived of my right to sleep peacefully upon my land due to hostile, alleged owners to buildings built upon my land. Over the years, I have personally been forced to sleep on the streets in the cold, in the heat, in the rain, and other natural (and unnatural conditions) by the usurpation agendas by States, Cities, and Counties upon the land. I have been under extreme duress, threat, and coercion by the City of Orlando, County of Orange, and overall State of Florida employees, administrators, commissioners, etc. And, due to my having made several national-related complaint issues to Ronald DeSantis, State of Florida Public Servant, directly, the aggression, hostility, stalking, spying / espionage, and racketeering against myself, by such persons, has become evident and left without my personal remedy. It is due to these stressful circumstances, that I must exercise my birthrights upon my land, as an Heir Apparent to my estate at North America.

On June 10, 2022, around approximately 3:28 am (Eastern Daylight Time), I was trespassed upon by three (3) City of Orlando Police Department employees. According to one of the unidentified, African-American police employees, they woke myself out of my peaceful slumber, alleging some sort of building alarm going off near where I have been forced to sleep for approximately three years, to date. Upon waking me from my sleep, the three police employees, one identified only as Montes (Badge Identification 35791), I was automatically assumed by the police employees, to be Negro, Black, Colored, etc., due to my not having my national Moroccan flag readily available prior to their trespass. By their willful negligence, all three police employees assumed that I am personally subject to City "ordinances" upon my land. They demanded my personal photo identification, which I happily declined due to the stalking activity I experienced from City of Orlando Police Department employees that I have experienced for approximately two years, to date. Montes, Badge Identification 35791 stated to me that I had to leave, since I was not willing to do commerce with them as they deprived me of my right to sleep, then blatantly conspired against myself, with firearms, in their trespass upon me on my land, with intentions to injure myself beginning with intimidation tactics. All three of the police employees had "body cams", which I had no idea which were actually on, as one of the other Caucasian male police employees intentionally shined his flashlight directly in my eyes, as to blind me and prevent me from seeing who he was, as well as to try to confuse me with the light distraction by military tactic. Overall, I was threatened to be kidnapped by force of being taken to the Orange County

Jail / Orange County Corrections Department facility, if I did not leave the said "scene" and if I returned to my normal place of sleep, on the hard concrete, next to a vacant building (unless someone is secretly residing in the building) between the said "streets", Kaley Street and South Orange Avenue, near Downtown Orlando, State of Florida. The vacant building, where the trespass against me took place, is right next to an Innovative Electronics — Radio Shack retail store operation, located at the public street address [2001 South Orange Avenue]. I was forced to leave the spot where I slept peacefully, under extreme threat by the three police employees.

After leaving the spot where I slept, I called the City of Orlando Police Department at their main office number [321-235-5300]. I spoke with an employee by the name of Madeline, who answered the call. I explained to Madeline what the police employees did and how I was mistreated by their Color-of-Law practice against myself. Madeline confirmed my complaint and provided Complaint Number: 2022-201583 for the record. During my call, I clearly explained the situation and my circumstances to Madeline. She mentioned that the Supervisor for the employees, said "Corporal Johnson," was someone I could make my complaint to in regard to the negligent behavior of the police employees. I did make Madeline fully aware that the City of Orlando operatives (including the City of Orlando Police Department) were already warned in their untoward actions against myself. I made formal, written notice to Buddy Dyer via United States Certified Mail on October 7, 2021, confirmed delivered on October 12, 2021 and signed for by "J. Padilla". The notice that I personally mailed to Buddy Dyer consisted of my previous Color-of-Law Violations warning for a very similar trespass against myself, by another City of Orlando Police Department employee, which took place back in July 2021. At this time, I am simply making a peaceful command that this complaint be fully submitted, filed, and placed on the United States Justice Department / United States Department of Justice record for lawful action in my complete remedy to this matter, by the very torts made by the police employees. I am also making a peaceful command that all City of Orlando Police Department employees, all Orange County Sheriff's Office employees, all public and private, armed and / or unarmed Security Agencies, etc., immediately 'Cease & Desist' all Color-of-Law actions and activities (surveillance included) against myself, through or by any and all statutes, ordinances, codes, etc., as I am not a U.S. Citizen.

By this clear, constructive notice, I am expecting rapid response to this national complaint submission, as well as the full remedy for the ongoing injuries that I have suffered by the Color-of-Law practices conducted by not only City of Orlando employees (including City of Orlando Police Department), but also County of Orange / Orange County employees, citizens, Commissioners, and Public Servants, operating through the State of Florida / STATE OF FLORIDA, united States of America / UNITED STATES OF AMERICA.
