This addendum is for the addition of information in the identification of a corporate entity operating at North America. The entity is currently identified as: STRATEGIC SECURITY CORP. / CORPORATION. This public entity alleges to offer security services to businesses and their private and / or public persons operating such agencies through the UNITED STATES OF AMERICA et. al. The entity is currently operated by Christie Sordi, said to be the [Chief] Executive Officer (Public Servant), along with Joseph Sordi, said to be the Senior Vice [President] to the corporation.

This entity identified as STRATEGIC SECURITY CORP. / CORPORATION operates in conjunction with [U.S.] said "government" agencies, doing business at North America. The agency owner(s), Christie Sordi et. al., states to employ over 3,500 employees, specializing in "Guard Services", "Emergency Response", "Executive Protection", "Integrated Technology, "A.I.", and "Temporary Life Support" facilities, predominantly around North American territory, but also around other parts of the world. These types of agency operators have made public statements by "Mission Statements", having already created a gradually-building public hysteria against natural people exercising peaceful rights (or forced self-defense) due to unlawful, corporate policies (outside of human rights) and illusory Democracy assumptions, by intentional miseducation to the true public interest and aggressive financial power, by the financially-privileged persons doing business at North America.

The STRATEGIC SECURITY CORP. entity persons / operatives were indeed hired by persons / operators to CENTRAL FLORIDA REGIONAL TRANSPORTATION [AUTHORITY] d / b / a LYNX, which is operated by employees working directly out of the LYNX CENTRAL STATION building, DOWNTOWN ORLANDO, at the following public address to the UNITED STATES / UNITED STATES OF AMERICA: 455 NORTH GARLAND AVENUE, ORLANDO, STATE OF FLORIDA, with James E. Harrison as the current said [Chief] Executive Officer for LYNX, alleging to provide public bus services with respect to local public communities and their needs.

Consequently, Ilhahi Ankaa Bey, an aboriginal and indigenous Moor / Muur — Al Moroccan / American, one of the Heirs to the North Gate Estate / North America was indeed Human Trafficked as a direct result of willful gross negligence committed by the persons operating under the LYNX corporation, and quite a few of its contractually subject employees, along with CITY OF ORLANDO POLICE DEPARTMENT employees and ORANGE COUNTY SHERIFF'S OFFICE employees,

initiated by fraudulent corporate [TRESPASS] allegations made against Ilhahi Ankaa Bey on 26 January 2021 [A.D.], between the hours of 7:00 am and 8:00 am (Eastern Daylight Time), with a false pretense leading to kidnapping, made by Felix Torres with the LYNX SECURITY DEPARTMENT. The assault and kidnapping of Ilhahi Ankaa Bey, by CITY OF ORLANDO POLICE DEPARTMENT agents / employees, resulted in Ilhahi Ankaa Bey having been Human Trafficked at ORANGE COUNTY CORRECTIONS DEPARTMENT / ORANGE COUNTY JAIL, by staff and employee persons, from approximately 26 January 2021 [A.D.] to approximately 3 March 2021 [A.D.], while fraudulently misidentified as a 'Man-of-Straw' construct, "JOHN DOE", then fraudulently switched to ILHAHI A. BAY and / or ILHAHI ELBEY and / or IHLAHA A. BAY (with possibly other corporate construct variations), all while the natural person, lawfully identified as Ilhahi Ankaa Bey, was held hostage at the ORANGE COUNTY CORRECTIONS DEPARTMENT / ORANGE COUNTY JAIL building, ORLANDO, STATE OF FLORIDA.

The kidnapping of Ilhahi Ankaa Bey seemed clearly to be the direct result of an internal conspiracy conducted by citizens / employees (public and private) / persons of CITY OF ORLANDO and / or ORANGE COUNTY / COUNTY OF ORANGE, STATE OF FLORIDA. During the kidnapping, and having been held hostage for approximately thirty-three (33) days, Ilhahi Ankaa Bey suffered many attacks by ORANGE COUNTY CORRECTIONS DEPARTMENT / ORANGE COUNTY JAIL facility GUARDS persons, alleged to be [CORRECTIONS OFFICERS]. Under complete threat, duress, and coercion, he was subjected to cruel and unusual punishments administered by the MENTAL HEALTH DEPARTMENT employees / citizens / persons, operating directly out of ORANGE COUNTY CORRECTIONS DEPARTMENT / ORANGE COUNTY JAIL, including various corporate persons / actors taking direct orders to support the fraud, including (but not limited to) forced fingerprinting (theft of finger prints) in an attempt to validate some other 'Man-of-Straw' construct(s) possibly administered by other corporations operating at North America and feigning as said "government".

Overall, the systematic attacks by citizens / employees / persons, were believed to be the direct result of Ilhahi Ankaa Bey initiating support to his unalienable and inalienable birthrights, against constant attacks from citizens / employees / persons operating through CENTRAL FLORIDA REGIONAL TRANSPORTATION [AUTHORITY] – d / b / a LYNX. The attacks began after Ilhahi Ankaa Bey made formal, written complaints due directly to ongoing mistreatment, fraud, and malfeasance by willfully negligent citizens / persons / employees operating through LYNX, continually ignoring his birthrights and practicing 'Color-of-Law' against him as an Heir to the estate upon which they operate for extreme financial profits. Ilhahi Ankaa Bey made adamant attempts to educate each involved persons and conspiring parties to *General Civil Orders – General Order 100*, made by Pope Francis back in 2014 [A.D.], for which all CITY OF ORLANDO / ORLANDO CITY and ORANGE COUNTY / COUNTY OF ORANGE Commissioners and Employees and Citizens have blatantly ignored, with prejudice, to the ultimate injuries suffered by Ilhahi Ankaa Bey, to date.

To date, employee 'Security Guards' (identities still remain hidden) operating through STRATEGIC SECURITY CORP. / CORPORATION, use specific Caucasian / European agents to stalk and harass Ilhahi Ankaa Bey near the corporate CITY OF ORLANDO, upon the estate, simply for his being forced

to use the public bus system for his forced labor work and travel needs to live (in Peace) upon his estate (among overly-privileged foreigners treated as first-class people by false status). They proved that they are fully aware of Ilhahi Ankaa Bey's identity and birthright status, by their having openly acknowledged notices sent to Buddy Dyer, ORLANDO CITY HALL, within the past year due to the ongoing mistreatment. However, they choose to continue to conduct psychological warfare against Ilhahi Ankaa Bey, through various methods of stalking and military espionage (by surveillance and technology methods) and intimidation tactics to forcefully promote fear in Ilhahi Ankaa Bey, while he pursues his own personal happiness, for all that he has suffered in his life up to this very day.

At this time, Ilhahi Ankaa Bey has placed full financial and personal liabilities (per General Civil Orders - General Order 100) against all current (and future) persons involved, as rightful claim to monetary compensation (up to 5,000,000 [U.S.\$] / Notes per count of offense, per each person involved) from any and all violating Public Servants and Commissioners and Employees and Citizens (public or private), operating through COUNTY OF ORANGE / ORANGE COUNTY, CITY OF ORLANDO / ORLANDO CITY, and the STATE OF FLORIDA / State of Florida / Florida State, etc., all doing business at North America. In addition to the monetary compensation, all persons, citizens, employees, and other involved parties to conspiracy against Ilhahi Ankaa Bey, can face prison time for their offenses against an Heir to the estate, upon which they all have profited from aggressively and maliciously, by the suffering of, abuses against, violations against, and total disenfranchisement of Ilhahi Ankaa Bey. This affidavit is an addendum to the already published International Press Release & Public Notice, posted as Lawful / Legal Evidence, on the 12^{th} Day of February 2022 [A.D.] and deemed valid by the International Law mandates already in place for full reparations for injuries to nationals, with Ilhahi Ankaa Bey being an Al Moroccan national, inhabiting North America from natural birth, which is indeed the heart of the Al Moroccan Empire (irrespective of feuding secret and political parties denying its existence), with full treaty law recognition and complete treaty enforcement (*See Article VI – constitution for the united States of America / united states of America major / United *States Republic constitution* – **Supremacy Clause**).

I, Ilhahi Ankaa Bey, declare that the above statements are true, correct, and factual, to the best of my knowledge, actual experience, and honourable intent under the circumstances of direct suffering. Any and all records to the above claims I made can be lawfully investigated and proven by any and all international and domestic proper parties of interest, for bona fide International Law remedies. Furthermore, the following are the accused parties pertaining to the overall injuries suffered by Ilhahi Ankaa Bey for this particular International Public Notice: Ronald DeSantis, Buddy Dyer, Jerry L. Demmings, Orlando Rolon, John Mina, Christie Sordi, and other associations involved, all doing business through the corporate STATE OF FLORIDA / State of Florida et. al. 4.24
