**COMPLAINT FOR REVIEW UNDER THE ADMINISTRATIVE
PROCEDURE ACT AND FOR WRIT OF MANDAMUS**

Claimant / Plaintiff, Ilhahi Ankaa Bey, Aboriginal and Indigenous to North America / united States of America Republic, filed a Legal Notice of Removal concerning STATE OF FLORIDA Administration Judicial Misconduct on various counts of Color-of-Law, Deprivation of Rights violations, conducted by City and County Police agencies allowing their agents to blatantly violate the Constitution for the united States of America Republic of 1787 A.D. The Legal Notice of Removal was filed by a direct deposit into United States Postal mail on June 12, 2026 as United States Registered Mail, Article Number: RE 267 875 284 US. Now, it has been well over 30 days since the filing, while the Claimant / Plaintiff received no response / correspondence from Scott S. Harris,

Supreme Court of the United States Clerk of the Court. By virtue of Constitutionally-secured rights, particularly Bill of Rights – 5th Amendment, the Due Process clause entitled to the Claimant / Plaintiff has been ignored by the Supreme Court of the United States Clerk of the Court. A Thirty (30) day timeframe is more than adequate and ample time for proper correspondence from any Clerk of Court, for dockets and case submissions, leading to lawful reviews for Claimants / Petitioners seeking remedies for lawful grievances under adverse State, City, and County Constitutional violations circumstances.

JURISDICTION

1. This Court has original and appellate jurisdiction to hear this case under 28 U.S.C. § 1361, The Mandamus Act, and 28 U.S.C. § 1331, Federal Question Jurisdiction. This matter arises under 5 U.S.C. §§ 701-06, the Administrative Procedure Act, and The Mandamus Act.

VENUE

2. The Supreme Court of the United States / United States Supreme Court is a proper federal venue for this action under 28 U.S.C. § 1391(e)(1)(C) because the Defendant is an officer of the United States, Claimant / Plaintiff is part and parcel to the United States, and no real property is involved in this particular action.

THE PARTIES

3. Claimant / Plaintiff Ilhahi Ankaa Bey filed a Legal Notice of Removal, which is the subject of this lawful action submitted to the Supreme Court of the United States.
4. Defendant Scott S. Harris is the Supreme Court of the United States Clerk of the Court. He has been the United States Supreme Court liaison for communications between private and public parties seeking legal and lawful remedies for grievances caused by violations of the Constitution for the United States of America Republic, conducted by any and all parties demonstrating or operating by willful negligence against the United States Republic Constitution, with lawful remedies already prescribed by proper, historical stare decisis and res judicata case laws (deemed Common Law), as well as by United States Republic Codes of Law and Federal Statutes, that undeniably preserve and protect rights belonging to the people (Bill of Rights – 9th and 10th Amendments).
5. The Defendant is being placed on Public Notice to perform his obligated fiduciary duties, honorably while utilizing his office as Clerk of the Court for the Supreme Court of the United States, as he has been an obligated party to initiate hearings / reviews, by docket, for any and all

violations of the Constitution for the united States of America Republic 1787.

FACTUAL ALLEGATIONS

Legal Notice of Removal and Civil Action for Deprivation of Rights

6. Ilhahi Ankaa Bey suffered several torts over the course of six (6) years by the willful negligence and Color-of-Law (18 U.S.C., Section 242), Deprivation of rights, along with Conspiracy against rights (18 U.S.C, Section 241), conducted by STATE OF FLORIDA Administrative agents, operating via belligerent Domestic Police Forces agencies, who have been targeting Ilhahi Ankaa Bey for years, due to his being a Moorish American national (a free person, natural) and never any Ward of any State via United States.
7. With upright Moors having status upon the land, there should have never been any question as to jurisdictional authority, and any lacking thereof, concerning Domestic Police Force agents behaving like modern-day miscreants, out of whatever political controversy of status belonging to the American native nationals to the land / estate.
8. By direct and competent violations of rights belonging to Ilhahi Ankaa Bey, the STATE OF FLORIDA Administration agents immediately placed themselves at full liabilities to the matter, as they chose to operate in direct violations of the Constitution for the united States of America Republic 1787.
9. Along with the Legal Notice of Removal, a Certificate of Service was served upon the United States Supreme Court of Florida, to fully address their lower court miscreant operatives, by the Claimant / Plaintiff having deposited a copy directly into the United States Postal Mail on June 12, 2026.

Claimant / Plaintiff Civil Actions to Substantiate His Claim for Lawful Remedy

10. By Ilhahi Ankaa Bey having lawfully grieved the Color-of-Law violations conducted against himself by various persons / parties operating via State, City, and County administrations, the

Due Process owed to Ilhahi Ankaa Bey has been nothing less than a lawfully docketed case for the Legal Notice of Removal Civil Action for Deprivation of rights (28 U.S.C., Section 2254), inclusive of all Colored actions, which led to several injuries sustained by Ilhahi Ankaa Bey.

11. Scott S. Harris, Supreme Court of the United States Clerk of the Court, was mailed the Legal Notice of Removal directly via United States Registered Mail: RE 267 875 284 US, which has been confirmed delivered on June 29, 2026 at 8:02 am. The filing of such lawful case submissions, has been his sole responsibility for his office and cannot be arbitrarily denied to the Claimant / Plaintiff simply for the Claimant's / Plaintiff's national origin claim that has been ongoing challenging the blatant WANT OF JURISDICTION claim fraudulently conducted by the STATE OF FLORIDA Administration agents and their collusive City and County Municipality agencies, who willfully take part in ongoing Color-of-Law practices against the original inhabitants to the organic land here at North America.
12. On July 7, 2026, a copy of the Certificate of Service served directly upon the United States Supreme Court of Florida, was mailed directly to Scott S. Harris, Supreme Court of the United States Clerk of the Court, by the Claimant / Plaintiff depositing a copy into the United States Postal Mail via Certified Mail Article Number: 9589 0710 5270 4112 7594 71, which has been confirmed delivered on: July 16, 2026. The record substantiates the claim made by Ilhahi Ankaa Bey for his right to Due Process in the matter of Bey v. STATE OF FLORIDA Administration, with specific persons / parties named in the Civil Action for Deprivation of rights for the record.
13. Upon original submission of the Legal Notice of Removal, Scott S. Harris, Supreme Court of the United States Clerk of the Court was provided with updated direct contact information for Ilhahi Ankaa Bey, for proper and fair direct correspondence in the matter. In the letter communication for the contact information update, Scott S. Harris, Supreme Court of the United States Clerk of

the Court was informed that it would be best to email official correspondence (as done with other cases in the past) directly to Ilhahi Ankaa Bey, due to the created hindrance by direct torts caused against the Claimant / Plaintiff, caused by State, City, and County administration agents willful negligence, who now lacks a Mailing Location to receive lawful paper correspondence for the injuries sustained in the matter, which caused the need for the Legal Notice of Removal case submission in the first place.

14. As a current injured party, Ilhahi Ankaa Bey still suffers from what the STATE OF FLORIDA Administration agents caused via their City and County administration agents; having caused a Legal Notice of Removal to have been initiated in the matter for full remedy for Ilhahi Ankaa Bey.
15. At this time, Scott S. Harris, Supreme Court of the United States Clerk of the Court, has failed to properly docket the lawful case submission and correspond directly with the Self-Represented Claimant / Plaintiff in the matter. As a part of the proper Due Process clause by the Bill of Rights 5th Amendment, Ilhahi Ankaa Bey deserves proper docketing of the case, along with proper remedy within a reasonable amount of time of thirty (30) days for case docketing and correspondence at minimal for lawful remedy.

**FIRST CAUSE OF ACTION:
ADMINISTRATIVE PROCEDURE ACT –
COMPELLING UNITED STATES CONSTITUTIONAL OBLIGATIONS**

16. Claimant / Plaintiff seeks injunctive relief under the Administrative Procedure Act, 5 U.S.C. § 701 et seq.

Specifically, he petitions the United States Supreme Court to compel the Supreme Court of the United States Clerk of the Court to uphold their Oath to the Constitution for the united States of America Republic 1787, including their fiduciary duties to properly file and docket the Legal Notice of Removal submitted by Ilhahi Ankaa Bey and directly communicate any and all updates via the private email for the Claimant / Plaintiff, recently provided directly to Scott S. Harris, Supreme Court of the United States Clerk of the Court.

17. As a part of the original Due Process clause, such cases should take no more than sixty (60) days for full lawful remedy by overall reviewed dockets and honorable and reasonable adjudication in direct favor of the upholding of the Constitution for the united States of America Republic 1787, as obligated by Article III and Article VI, respectfully.
18. The STATE OF FLORIDA Administration can no longer be allowed to practice Color-of-Law and Color-of-Authority against Ilhahi Ankaa Bey, moving forward. The Claimant / Plaintiff has spent years proving that he has always been an upright native national upon his own land / estate.

**SECOND CAUSE OF ACTION: MANDAMUS –
CEASE AND DESIST COLOR-OF-LAW
ACTIONS AGAINST CLAIMANT / PLAINTIFF**

19. As an alternative to the first cause of action, Plaintiff seeks injunctive relief in the form of a lawful Writ of Mandamus effectuation.
20. Plaintiff petitions the United States Supreme Court to issue a Writ of Mandamus compelling the STATE OF FLORIDA Administration (and whatever collusive State(s)),

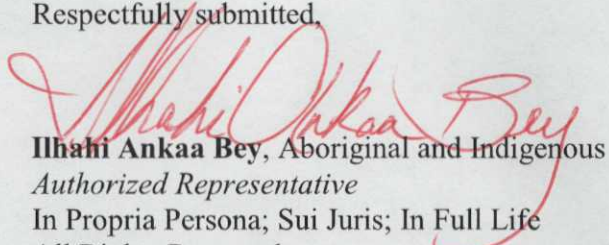

- c) Granting such other injunctive relief at law and in equity as lawful justice may require.

I.

ORIGINAL JURISDICTION

Jurisdiction / Venue are hereby placed in one Supreme Court, pursuant to Article III Section 2 for The United States Republic, and the several States, under the Constitution; Article VI; and reaffirmed by obligatory Official Oaths.

“The Judicial Power shall extend to all cases, in law and equity, arising under this Constitution, the laws of the United States, and treaties made, or which shall be made, under their authority;--to all cases affecting ambassadors, other public ministers and consuls; --to all cases of admiralty and maritime jurisdictions;--to controversies to which the United States shall be a party;--to controversies between two or more states;--between a state and citizens of another state;--between citizens of different states;--between citizens of the same state claiming lands under grants of different states, and between a state, or the citizens thereof, and foreign states, citizens or subjects.”

In all cases affecting ambassadors, other public ministers and consuls, and those in which a state shall be a party, the Supreme Court shall have original jurisdiction. In all the other cases before mentioned, the Supreme Court shall have appellate jurisdiction, both as to law and fact, with such exceptions, and under such regulations as the Congress shall make.

COMES NOW, Ilhahi Ankaa Bey, In Propria Persona, Sui Juris (not to be confused with Pro Se), Aboriginal and Indigenous Moorish-American; possessing Free-hold by Inheritance status; standing squarely affirmed and bound to the Zodiac Constitution, with all due respect and honors given to the Constitution for the United States Republic (1787 A.D.), North America. THE TREATY OF PEACE AND FRIENDSHIP OF 1836 A.D.
Between Morocco and the United States

Article 20

“If any of the Citizens of the United States, or any Persons under their Protection, shall have any disputes with each other, the Consul shall decide between the Parties, and whenever the Consul shall require any Aid or Assistance from our Government, to enforce his decisions, it shall be immediately granted to him.”

Article 21

“If any Citizen of the United States should kill or wound a **Moor**, or, on the contrary, if a **Moor** shall kill or wound a Citizen of the United States, the Law of the Country shall take place, and equal Justice shall be rendered, the Consul assisting at the Trial; and if any Delinquent shall make his escape, the Consul shall not be answerable for him in any manner whatever.”

Austin Boniface, Badge Number 11163, Orange County Sheriff's Office, private corporation; foreign to the United States Republic; and all COUNTY OF ORANGE / ORANGE COUNTY Employees; Agents; Officers; Contractors; Assignees, etc., being Plaintiffs, Claimants, or Parties of Interest in the 'Color-of-Law' processes instituted by them, or any one of them, against Ilhahi Ankaa Bey.
11. CITY OF ORLANDO / City of Orlando / ORLANDO CITY, corporation established in the year EIGHTEEN EIGHTY-FIVE (1885 A.D.), foreign to the organic Pennsylvania state Republic; and foreign to the United States Republic of North America.
12. James Baker, Badge Number Unknown, City of Orlando Police Department, private corporation; foreign to the United States Republic; and all CITY OF ORLANDO / City of Orlando / ORLANDO CITY Employees; Agents; Officers; Contractors; Assignees, etc., being Plaintiffs, Claimants, or Parties of Interest in the 'Color-of-Law' processes instituted by them, or any one of them, against Ilhahi Ankaa Bey.

Ilhahi Ankaa Bey, In Propria Persona, Sui Juris (not to be confused with Pro Se) Aboriginal and Indigenous Moorish American national / National, C/o GENERAL DELIVERY, Orlando Territory, Florida Republic [Postal Zone 8].

I, Ilhahi Ankaa Bey, In Propria Persona, Sui Juris; Aboriginal and Indigenous Moorish American national / National, Freehold by Inheritance with Birthrights and protected and secured Inalienable Rights, makes with this NOTICE OF REMOVAL of the unconstitutional Complaint – Summons / Ticket – Suit / Bill of Exchange / Action, Number(s) 48-2026-MM-400368-A-O, 48-2023-MO-008341-A-O, 48-2023-MM-001930-A-O under falsified identity Legal Fiction records created as misnomers: BEY, DHAHI (Case Number: 48-2026-MM-400368-A-O) and MASTERS, LUCAS (Case Numbers: 48-2023-MO-008341 and 48-2023-MM-001930-A-O), by James Baker with the City of Orlando Police Department and Austin Boniface, Badge 11163 with the Orange County Sheriff's Office, for the record. Claimant / Petitioner is with reasonable expectation that the Officers / Agents, and Officials, holding any position of Public Trust, or political office, are prohibited, under Official Oath, under the authority of The Law of the Land, from the use of the official position(s) or office(s) to violate the Constitution for the UNITED STATES

OF AMERICA; and thus, by the abuse of authority, and the practice of superseding their 'limited' jurisdictional powers, violate and abridge the Natural, Divine, Unalienable, and Secured Rights of the People; terminating with the cause of damage to this Claimant / Petitioner / Plaintiff.

III

CAUSE OF ACTION

On January 14, 2026, the Claimant / Petitioner / Ilhahi Ankaa Bey, while peacefully traveling near International Drive, was unlawfully detained by Policeman / Prosecuting Witness, Austin Boniface, Badge I.D. Number 11163; employed by the Orange County Sheriff's Office, who stated that Ilhahi Ankaa Bey (intentionally misidentified as BEY, DHAHI with ORANGE COUNTY CORRECTIONS DEPARTMENT Jail on January 14, 2026 A.D.) was in violation of Florida Statute 843.02 which is private policy (being classed as Law). Although the original allegation made by Austin Boniface was a violation of Florida Statute 316.155 and 876.12, Austin Boniface altered his sworn and notarized ICJIS Arrest Affidavit to accommodate his deceptive intention and Color-of-Law, Deprivation of rights practice (18 U.S.C., Section 242).

On December 4, 2023, the Claimant / Petitioner / Ilhahi Ankaa Bey, while sitting peacefully on land near a corporate building near Orange Avenue, was unlawfully detained by Policeman / Prosecuting Witness, James Baker, Badge I.D. Number Unknown; employed by the City of Orlando Police Department, who stated that Ilhahi Ankaa Bey (intentionally misidentified as MASTERS, LUCAS with ORANGE COUNTY CORRECTIONS DEPARTMENT Jail on December 4, 2023 A.D.) was in violation of Florida Statute 843.02, Florida Statute 125.0231 (Chapter 125 – COUNTY OF ORANGE / ORANGE COUNTY), and Florida Statute 901.36(1), which are private policies (being classed as Law). Although a private national identification card Ilhahi Ankaa Bey was secured by James Baker on site at the scene of the false allegations, James Baker blatantly ignored the three (3) national photo identifications held by Ilhahi Ankaa Bey at the time of the false arrest, under false pretenses. Consequently, James Baker fabricated a falsified identity record and Legal Fiction misnomer to use against Ilhahi Ankaa Bey, to falsify Personam jurisdiction in the matter with County Judge 9th Judicial Circuit on December 4, 2023. Ilhahi Ankaa Bey had no such MASTERS, LUCAS identification card or Driver's License on him during the Conspiracy against rights (18 U.S.C., Section 241), nor did Ilhahi Ankaa Bey identify himself verbally as MASTERS, LUCAS, for the record.

Ilhahi Ankaa Bey has been victimized by STATE OF FLORIDA, COUNTY OF ORANGE / ORANGE COUNTY, and CITY OF ORLANDO / ORLANDO CITY Agents; Employees; Contractors; Assignees, etc., who blatantly stole his physical fingerprints, digitized them for electronic transacting, and submitted them to the ORANGE COUNTY CORRECTIONS DEPARTMENT Jail Administration for Administrative Human Trafficking in persons (18 U.S.C., Chapter 77, Part I – Peonage, Slavery, and Trafficking in persons). Accounts were opened by staff and administrators with the ORANGE COUNTY CORRECTIONS DEPARTMENT Jail; BEY, DHAHI (Detention Account Number ID: 26001859); MASTERS, LUCAS (Detention Account Number ID: Currently Unknown).

Overall, the employees, staff, and Jail Administrators with the ORANGE COUNTY CORRECTIONS DEPARTMENT Jail, including (but not limited to) Louis A. Quinones Jr, Mr. Quesaradillo (Intelligence / Gang Unit), Mr. E Garcia-Frias, T. Rainge, Arthur G. Willis, and others, fraudulently subjected Ilhahi Ankaa Bey to a series of cruel and unusual punishments in violation of United States Republic Constitution – Bill of Rights Amendment VIII (8). Their objective was to conduct psychological warfare against Ilhahi Ankaa Bey, by slander him and conducting defamation of his character by having labeled him as some "Sovereign Citizen" corporate Federal Bureau of Investigations (FBI) label against Moors / Moorish Americans. In addition, Ilhahi Ankaa Bey suffered unlawful detentions (28 U.S.C., Section 2254) at ORANGE COUNTY CORRECTIONS DEPARTMENT Jail, dating all the way back to 2023.

The STATE OF FLORIDA, COUNTY OF ORANGE / ORANGE COUNTY, CITY OF ORLANDO / ORLANDO CITY, and County Judge 9th Judicial Circuit are unconstitutional, private corporations, not delegated by Congress, under Article III, Section 2 of the Constitution; and that the Agents, Employees, Contractors, Assignees, etc., do not, and did not provide 'Due Process' protected and secured for the People, by the Amendments IV, V, VI, VII, VIII, IX, and X of the United States Republic Constitution, to which the Judges, Magistrates, and Officers in every State have been bound (by Official Oath) to support and to uphold. Any statutory regulation, ordinance, or laws of any State, to the contrary, notwithstanding.

This allegedly - accused Claimant / Petitioner believes that in accord with the Substantive Rights retained by the Claimant / Petitioner, notifying all parties of the Claimant's / Petitioner's Moorish American (Identification / Status) and that the Claimant / Petitioner was not, is not, and does not, waive

any Inalienable Rights to due process; and affirmed that any action be adjudicated in a lawfully delegated jurisdiction and venue.

The Employees / Agents / Assignees / Officers of STATE OF FLORIDA commanded that the Claimant / Petitioner Pay Fines and Costs Imposed under threat, duress, and coercion with a 'man-of-straw' / misnomer word, misrepresented as implying my name, and typed upon the Order / Instrument, and was improperly spelled, "BEY, DHAHI", "MASTERS, LUCAS", and intentionally-entered (by physical data entry) misspelled variations thereof, in ALL CAPITAL LETTERS. That misnomer and CORPORATE - NAMES, "BEY, DHAHI", "MASTERS, LUCAS", and ALL misspelled variations thereof have been clearly (artificial – persons / entities); and were never me, the Natural Person; have been deliberate grammatical errors, intended for injury to myself; and was clearly never of consanguine relationship to myself or to my nationality (national origin), in any form, truth, or manner; nor to my Moorish Family Bloodline. This is in violation of my secured-rights to my nomen / name and free nationality; a violation of International Law; and a violation of the Obligations of the Officers of the Court; and a violation of their fiduciary duties and Official Oaths to uphold and to support Article VI of the United States Constitution; and thus, violating my Substantive Rights, and the Articles of Part 1 of '*The Rights of Indigenous People*' (https://www.un.org/development/desa/indigenouspeoples/wp-content/uploads/sites/19/2018/11/UNDRIP_E_web.pdf) as follows:

"Indigenous People have the right to a full and effective enjoyment of all human rights and fundamental freedoms recognized in the Charter of the United Nations; The Universal Declaration of Human Rights; And International Human Law."

Article 5 of the *Rights of Indigenous People*

"Every Indigenous individual has the Right to a Nationality."

Article 15 of the *Declaration of Human Rights* (<http://www.un.org/Overview/rights.html>)

everyone has a right to a nationality. (2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his name."

This Claimant / Petitioner made a "*Reservation of Rights*" under the malfeasance conducted by the STATE OF FLORIDA, COUNTY OF ORANGE / ORANGE COUNTY, and CITY OF ORLANDO / ORLANDO CITY Agents, Employees, Contractors, Assignees, etc., as he never waived any of his rights and the WANT OF JURISDICTION claims made by ALL involved parties, was never lawfully proven; instead Ilhahi Ankaa Bey has always been under threat, duress, and coercion conducted by the involved parties who caused him to be held hostage at the ORANGE COUNTY CORRECTIONS DEPARTMENT Jail for an accumulated, approximate six (6) months under the Legal Fiction misnomers in All matters whereas the STATE OF FLORIDA was portrayed as a corpus delicti (injured party), for the record.

Plaintiff(s) Austin Boniface, Badge Number 11163 and James Baker, Badge Number Unknown is with the 'want of jurisdiction' by knowingly and willingly conspiring (under a Color-of-Authority) to deny this Claimant / Petitioner, Ilhahi Ankaa Bey (after his national identification cards were witnessed by Austin Boniface and his three (3) co-workers on January 14, 2026, as well as him stating on bodycam that he is a Moor / Moorish American), his Inalienable Rights, the right to a Name and Nationality of his choosing, etc. The State / Judge / Accuser(s) alleged and assumed the Claimant / Petitioner of being a Corporate Ward-ship 14th Amendment Artificial Negro Person / citizen / subject, which resulted in an unlawful arrest-of-rights, immunities and liberties; which is in direct contradiction to, and a violation of, the Fourth (IV) Amendment of the Constitution for the United States (Republic); violating Article VI of the Constitution, by way of violating The Treaty of Peace and Friendship of EIGHTEEN HUNDRED-THRITY-SIX (1836) A.D.; Congressional Resolution # 75, Philadelphia Pennsylvania; a violation of Article 15 of 'The Universal Declaration of Human Rights' of Nineteen Hundred and Forty-Eight (1948) A.D. – General Assembly, United Nations; a violation of '*The Declaration of the Rights of The Child*' of Nineteen Hundred and Fifty-Nine (1959) A.D. (<http://www.un.org/cyberschoolbus/humanrights/resources/child.asp>); and violating '*The Rights of Indigenous Peoples*'; and that the Employees / Officers / Agents of THE STATE OF FLORIDA knowingly committed 'fraud' against the Claimant / Petitioner (Ilhahi Ankaa Bey) by abusing their authority, in that they failed to correct a known violation; and did not aid in preventing said such abuse of authority, while having (by Law) the obligation to do so; and violated the Fifth Amendment of The Bill of Rights of Seventeen Hundred and Ninety-One (1791) A.D.; impeding the Peoples' **right to due process under the Law, and equal protection of the Law**, Article 1 Section 10 of The Constitution for The United States of America (Republic) which secures this Claimant / Petitioner the right to

contract and conspiracy to commit fraud against this Claimant / Petitioner and against the United States Republic.

IV

CONCLUSION

- 1) It is a sin for any group of people to violate the Constitutional Laws of a Free National Government.
- 2) The Delegates, which comprise the majority of Aboriginal and Indigenous Freeholders, by Birthright, Inheritance, and Primogeniture, and declared 'for the record' and known by the consanguine / Pedigree of their / our Forefathers, as Moors / Muurs; and the European Colonial Settlers of the United States of America, did, on the fifteenth day of November in the year Seventeen Seventy-seven (1777), and in the second year of the Independence of The United States of America, agreed to certain *Articles of Confederation* and perpetual Union between the States of New Hampshire, Massachusetts Bay, Rhode Island, and Providence Plantations, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina and Georgia; wherein they did declare that the style of the Confederacy shall be the United States of America.
- 3) All parties to the *Articles of Confederation* of 1778 A.D. did also agree that *Article IX* shall set forth the procedure for resolving a dispute brought before the Congress of the United States by a freely associated compact State of the United States of America.
- 4) All parties to the *Articles of Confederation* of 1778 A.D. did also agree that no Congress shall thereafter alter *Article IX* of the *Articles of Confederation* unless it has received confirmation to do so by every State in the Union (*Article XIII* of the *Articles of Confederation*).
- 5) The United States, pursuant to an "Act" of the States sitting in Congress under the *Articles of Confederation* of Seventeen Hundred and Seventy-Eight (1778) A.D., authorized a Constitutional Convention for the purpose of forming a more perfect Union, to establish justice, to insure domestic tranquility, to provide for the common defense, to promote general welfare, and to secure the blessings of liberty, did ordain and established a Constitution for the United States. The Constitution for the United States was declared to be a "revision" to the *Articles of Confederation* of 1778 (*REPORT OF PROCEEDINGS IN CONGRESS*, Wed., Feb.21, 1787 [*Journals of the Continental Congress*, vol. 38]).
- 6) The Constitution for the United States was established by the People of the United States of America, and not by the States in their sovereign capacity (*In reg Opinion of the Justices*, 107 A. 673, 674, 118 Me. 544, 5 A.L.R. 1412) and was ratified by the People sitting in Convention of the Original 13 States of the United States of America (*United States Constitution*, VII: 1:1).
- 7) The Constitution for the United States is a Compact which constitutes a binding trilateral Contract between the People, the freely associated compact States of the United States of America, and the United States [e.g. *Article 10* of the *Bill of Rights* to the *Constitution of the United States*] (*In reg Opinion of the Justices*, 107 A. 673, 674, 118 Me. 544, 5 A.L.R. 1412).
- 8) By the wording of *Article VI* of the *Constitution for the United States*; the Congress is required to review its legislation from time to time to determine if the legislation was made pursuant to the provisions of that Constitution.
- 9) The parties to the Compact of the United States Constitution further agreed that the enumeration in the Constitution of certain Rights shall not be construed to deny or disparage others retained by the People (*Article 9* of the *Bill of Rights* to the *Constitution for the United States*).
- 10) The parties to the Compact also agreed that the Powers not delegated to the United States under the U.S. Constitution are reserved to the States or to the People (*Article 10* of the *Bill of Rights* to the *Constitution for the United States*).
- 11) On February 24, 1855; the Congress of the United States created the United States Court of Claims. The Court of Claims was authorized to execute the mandates of *Article IX* of the *Articles of Confederation* of 1778 and *Article I* of the *Bill of Rights* to the *Constitution for the United States* (10 Stat. 612, sec. 1, sec. 7)

- 12) The Congress of the United States also enacted the "*Bowman Act*" of March 3, 1883 (22 Stat. 485) and the "*Tucker Act*" of March 3, 1887 (24 Stat. 505) to clarify the jurisdiction of the Court of Claims. Under these Acts, either House of Congress may submit any claim or matter to the United States Court of Claims for investigation and determination of facts. The Court was to report its findings back to Congress for Congressional determination.
- 13) Notwithstanding the limitations imposed upon the United States Claims Court by *P.L. 97-164* and its subsequent United States Court of Federal Claims by *P.L. 102-572*; the Congress of the United States is barred by *Article IX* and *Article XIII* of the *Articles of Confederation* and by *Article I* of the *Bill of Rights* to the *Constitution for the United States* to limit its investigations to moneyed claims.
- 14) The continual refusal of the United States Congress to resolve the Petitions of Grievances that were submitted to it, by the several States of the Union, violates the "*Good Faith*" agreement that all grievances submitted would be expeditiously resolved as mandated by the *Articles of Confederation* of 1778.
- 15) Between the years of 1866 A.D. and 1868 A.D. (and other years); several states within the United States known as "States" submitted Petitions to the Congress of the United States for Redress of Grievances. These Petitions have passed from Congress to Congress for over one hundred years, with the Congress refusing to take any action to resolve the disputes as required by *Article IX* of the *Articles of Confederation* of 1778 and *Article I* of the *Bill of Rights* to the *Constitution for the United States*. These Petitions challenged the procedure by which the Congress used to amend the Constitution for the United States. The Amendments in question are the unlawfully - ratified 13th, 14th and 15th Amendments (hereinafter referred to as the "Three Dead Badges of Law").
- 16) "No change in ancient procedure can be made which disrupts those fundamental principles, which protect the citizen in his private right and guard him against the arbitrary action of the government." *Ex Parte Young*, 209 US 123.
- 17) The Constitution for the United States of America Republic binds all judicial officers at Article 6, wherein it does say, "This Constitution and the Laws of the United States which shall be made in pursuance thereof, and all Treaties made, or which shall be made under the authority of the United States, shall be the Supreme Law of the Land, and the Judges of every State shall be bound thereby, anything in the Constitution or laws of any state to the Contrary, notwithstanding," see Clause 2.
- 18) Black's Law Dictionary 4th Ed. Defines "*Law of the land*", - When first used in Magna Charta, the phrase probably meant the established law of the kingdom, in opposition to the civil or Roman law. It is now generally regarded as meaning general public laws binding on all members of the community. *Janes v. Reynolds*, 2 Tex 251; *Beasley v. Cunningham*, 171 Tenn. 334. 103 S.W.2d 18, 20110 A.L.R. 306. It means due process of law warranted by the constitution, by the common law adopted by the constitution, or by statutes passed in pursuance of the constitution *Mayo v. Wilson*, 1 N.H. 53.
- 19) Clause 3, clarifies the scope of this requirement when it states that "...All judicial officers, both of the United States and of the several states shall be bound to support this Constitution..."
- 20) The 5th Amendments require that all persons within the United States must be given due process of the law and equal protection of the law.
- 21) The unconstitutional charges being applied to this Claimant / Petitioner are not in pursuance of the Constitution for the United States of America Republic, wherein it does guarantee, and this Claimant / Petitioner does declare the equal protection of the right to "life liberty and the pursuit of happiness" in the 1st Amendment, which includes the right to travel (even by walking) as evidenced in positive law and stare decisis, to wit; *Chicago Motor Coach v. Chicago* 169 NE 221 "the use of the highways for the purpose of travel and transportation is not a mere privilege, but a common fundamental right of which the public and individuals cannot rightfully be deprived"; *Teche Lines v. Danforth*, Miss. 12 So 2nd 784, 787 "the right to travel on the public highways is a constitutional right", *Slusher v. Safety Coach Transit Co.*, 229 KY 731, 17 SW 2D 1012, affirmed in *Thompson v. Smith* 154 S.E. 579 - "The right to travel upon the public highways and transport my property thereon, by automobile is not a mere privilege, which may be permitted or prohibited at will, but a common right which one has to life, liberty and the pursuit of happiness" and the State's application of 625 ILCS 5/et seq is "notwithstanding", Article VI cl.2 Ibid.
- 22) The Petitioner claims full and equal protection of the Law in *Marbury v. Madison* 5 US 137 - "The Constitution of these United States is the Supreme Law of the Land. Any law, that is repugnant to the Constitution, is null and void of law."

- 23) The unconstitutional charges being applied to the Petitioner are repugnant to the Constitution because they deny a right established and guaranteed in the 1st, 4th, 5th, 6th, 7th, 8th, 9th, and 10th Amendments, and in United States Supreme Court 'Stare Decisis' so noted above, where this court has no authority to adjudicate contrary.
- 24) The unconstitutional charges under which the Petitioner is being forced to answer are non-constitutional on their face and unconstitutional when applied to the Petitioner because they do not have an enacting clause or single subject title, thereby denying due process of law.
- 25) Due Process of law is not necessarily satisfied by any process which the Legislature may prescribe. See: *Abrams v. Jones* 35 Idaho 532, 207 P. 724.
- 26) "Due Process of Law in each particular case means such an exercise of the powers of the government as the settled maxims of law permit and sanction; and under such safeguards for the protection of individual rights as those maxims prescribe for the class of cases to which the one in question belongs." *Cooley, Const. Lim.* 441.
- 27) Due Process as defined in H. C. Black's Law Dictionary, 4th Edition. "Whatever difficulty may be experienced in giving to those terms a definition which will embrace every permissible exertion of power affecting private rights, and exclude such as is forbidden, there can be no doubt of their meaning when applied to judicial proceedings. They then mean a course of legal proceedings according to those rules and principles, which have been established in our systems of jurisprudence for the enforcement and protection of private rights."
- 28) "To give such proceedings any validity, there must be a tribunal competent by its constitution—that is by the law of its creation—to pass upon the subject-matter of the suit; and if that involves merely a determination of the personal liability of the defendant, he must be brought within its jurisdiction obey service of process within the state or his voluntary appearance. *Pennoyer v. Neff*, 95 U.S. 733, 24 L.Ed. 565."
- 29) "Due process of law implies the right of the person affected thereby to be present before the tribunal which pronounces judgment upon the question of life liberty, or property, in its most comprehensive sense; to be heard, by testimony or otherwise, and to have the right of controverting, by proof, every material fact which bears on the question of right in the matter involved."
- 30) "If any question of fact or liability be conclusively presumed against him, this is not due process of law, *Zeigler v. Railroad Co.*, 58 Ala. 599.
- 31) These phrases in the Constitution do not mean the general body of the law, common and statute, as it was at the time the Constitution took effect; for that would seem to deny the right of the Legislature to amend or repeal the law. They refer to certain fundamental rights which that system of jurisprudence, of which ours is a derivative, has always recognized. *Brown v. Levee Com'rs* 50 Miss. 468."
- 32) All orders or judgments issued by a judge in a court of limited jurisdiction must contain the findings of the court showing that the court has subject-matter jurisdiction, not allegations that the court has jurisdiction. *In re Jennings*, 68 Ill.2d 125, 368 N.E.2d 864 (1977) ("in a special statutory proceeding an order must contain the jurisdictional findings prescribed by statute.")
- 33) *In Interest of M.V.*, 288 Ill.App.3d 300, 681 N.E.2d 532 (1st Dist. 1997). Without subject-matter jurisdiction, all of the orders and judgments issued by a judge are **void** under law, and are of no legal force or effect. *In Interest of M.V.*, 288 Ill.App.3d 300, 681 N.E.2d 532 (1st Dist. 1997) ("Every act of the court beyond that power is void").
- 34) The Petitioner assert, *Midland Coal Co. v. Knox County*, 268 Ill.App.3d 485, 644 N.E.2d 796 (4th Dist. 1994) ("Special statutory jurisdiction is limited to the language of the act conferring it, and the court has no powers from any other source"...)
- 35) The "language of the act" the complainants confer upon "has no powers from any other source" *Midland Coal Co. v. Knox County*, *Ibid*, no evidence on it's face of valid law, as it lacks the mandatory enacting clause,
- 36) That the purpose of thus prescribing an enacting clause — "the style of the acts" — is to establish it; to give it permanence, uniformity, and certainty; to identify the act of legislation as of the general assembly; to afford evidence of its legislative statutory nature; and to secure uniformity of

identification, and thus prevent inadvertence, possibly mistake and fraud. *State v. Patterson*, 4 S.E. 350, 352, 98 N.C. 660 (1887); 82 C.J.S. "Statutes," § 65, p. 104; *Joiner v. State*, 155 S.E.2d 8, 10, 223 Ga. 367 (1967).

37) "That the almost unbroken custom of centuries has been to preface laws with a statement in some form declaring the enacting authority. The purpose of an enacting clause of a statute is to 'identify' it as an act of legislation by expressing on its face the authority behind the act." 73 Am. Jur.2d, "Statutes," § 93, p. 319, 320; *Preckel v. Byrne*, 243 N.W. 823, 826, 62 N.D. 356 (1932).

38) That for an enacting clause to appear on the face of a law, it must be recorded or published with the law so that the People can readily identify the authority for that particular law.

39) That "It is necessary that every law should show on its face the authority by which it is adopted and promulgated, and that it should clearly appear that it is intended by the legislative power that enacts it that it should take effect as a law." *People v. Dettenthaler*, 77 N.W. 450, 451, 118 Mich. 595 (1898); citing *Swann v. Buck*, 40 Miss. 270.

40) This Plaintiff (a court of limited jurisdiction), lacks the power to act and have proceeded beyond the strictures of the statutes, and that the statutes being applied are created from revised statutes and codes of a foreign and unidentified source, as they fail to show from what authority in law they exist, where they fail to show on their face, the mandatory enacting clause.

41) Said revised statutes and codes fail to show a necessary and mandatory enacting clause on their face, giving them lawful force and effect. Said revised statutes and codes are private codes and statutes and are not law, do not compel this Petitioner to perform and do not apply to him, and fail to show "authority for the court to make any order." *Levy. Industrial Common Ibid, Midland Coal Co. v. Knox County, Ibid.*

42) The Petitioner, demand all rights under the common law based upon the status as a matter of due process of law and to determine what legal rights the Petitioner has in this court and what rights will be denied, if any, to determine what jurisdiction the Plaintiff is attempting to apply to this Natural Born Citizen.

43) The Claimant / Petitioner was never subject to the jurisdiction of All involved Plaintiffs in the matter(s).

44) This Claimant / Petitioner has no contract with the STATE OF FLORIDA / State of Florida, COUNTY OF ORANGE / ORANGE COUNTY, and CITY OF ORLANDO / ORLANDO CITY, or with the County Judge 9th Judicial Circuit, Law Offices of Melissa Vickers d / b / a Office of the Public Defender, City of Orlando Police Department, Orange County Sheriff's Office, ORANGE COUNTY CORRECTIONS DEPARTMENT Jail, Florida Department of Law Enforcement, Florida Crime Information Center (FCIC) Clearinghouse Electronic Database, National Crime Information Center (NCIC) Clearinghouse Electronic Database; or with any other segment of the United States of America that can grant jurisdiction over human rights; or over political, economic, social and cultural rights of Indigenous Peoples.

45) The Claimant / Petitioner is Aboriginal / Indigenous within the meaning of the description of the Draft Declaration of the Inter-American Declaration of the Rights of Indigenous Peoples at Article 1 Definition:

46) "In this Declaration Indigenous Peoples are those who embody historical continuity with societies which existed prior to the conquest and settlement of their territories by Europeans..."

47) Indigenous People are separate and distinct; alien to this administration; and have a separate and distinct status from the administrators of the colonial occupiers of the land; as recognized in the Declaration on Principles of International Law of Friendly Relations and Cooperation Among States; wherein it does say under the Principles of Equal Rights and self determination of Peoples (B5): "The territory of a colony or other Non-Self Governing Territory has, under the Charter, a status separate and distinct from the territory of the State administering it..."

48) Colonial legislatures were divested of their legislative powers, and required to transfer jurisdiction and all powers over the cultural rights of indigenous and minority peoples to those peoples and prohibited from making any law that effects the rights of indigenous people to fully and effectively enjoy their right to self-determination in Article 5 of the Declaration on the Granting of Independence to

Colonial Countries and Peoples, Adopted by General Assembly resolution 1514 (XV) of 14 December 1960. See Article 5 to wit: "Immediate steps shall be taken, in Trust and Non-Self Governing Territories or all other territories which have not yet attained independence, to transfer all powers to the peoples of those territories, without any conditions or reservations, in accordance with their freely expressed will and desire..."

49) Colonial courts were divested of, and required to, transfer the judicative power and all power to the people of this territory, *ibid*.

50) See 'The American Declaration of the Rights and Duties of Man' (Adopted by the Ninth International Conference of American States Bogota, Colombia, 1948 at Article 5, Article 17, Article 26)

51) The United States of America is required to obey the requirements of the Declaration on the Principles of International Law and to obey the principles of international law enumerated therein.

52) The Vienna Convention on the Law of Treaties requires that the United States of America fulfill its obligations incurred thereunder.

53) The United States of America is a member of the United Nations, and is bound by the Charter of the United Nations to promote and protect the Rights of Indigenous Peoples.

54) The Declaration of the Granting of Independence to Colonial Countries and People UN GA #1514 specifically required the United States of America to transfer *all power* to the peoples of this land, and this specifically includes all legislative, executive and judicial powers.

55) The STATE OF FLORIDA / State of Florida through its commercial agencies, on the Driver's License, and other misrepresented Instruments, has committed 'fraud' to accomplish what is called in legal contemplation, "*Capitis Diminutio Maxima*", which has been that my natural nomen / name has been murdered and I was resurrected as a non-natural, created entity subject to regulation and denied the protections of national and international law. This constitutes Fraud and denies due process of the law and the Freedom from the Practices and Policies of Apartheid described in the International Convention on the Suppression and Punishment of the Crime of *Apartheid* Adopted and opened for signature, ratification by General Assembly resolution 3068 (XXVIII) of 30 November 1973 at Articles 1, 2 and 3, and the right not to be compelled to perform under any contract or agreement not entered into voluntarily, intentionally and knowingly.

56) **Executive Order Number: 13107**, 63, Federal Register, 68,991 (1998)- Implementation of Human Rights Treaties, which states "It shall be the policy and practice of the Government of the United States, being committed to the protection and promotion of human rights and fundamental freedoms, fully to respect and implement its obligations under the international human rights treaties to which it is a party including the ICCPR, the CAT and the CERD.". County Judge 9th Judicial Circuit, by way of its Magistrates, Agents, Employees, Prosecutors, Officers, Assignees, etc., violated 'Due Process' and, conspired to deprive rights of the Claimant / Petitioner; and did neglect to prevent deprivation of rights at Title 18, U.S.C. 241 and Title 18, U.S.C. 242.

57) *Maine v. Thiboutot* 448 US 1, 100 SCT 2502 – Officers of the court have no immunity, when violating a constitutional right from liability. For they are deemed to know the law.

58) Note that the presiding Magistrate(s) / Judge(s), and any Judge acting as organ of the court, is aware that 42 USC 1986 requires the person(s) adjudicating legal processes, to correct wrongs, and that their failure to correct the wrongs that were addressed constitutes Fraud under Rule 9(b) of the FRCP, cross referenced to 28 USC 1746, and that this Fraud constitutes a Perjury on the Oath of Office at 18 USC 1621, deprives us of rights, at 18 USC 241, and 242, Conspires to deprives rights at 42 USC 1985; is an extortion of rights at 18 USC 872, and is actionable under **42 USC 1983 – Civil Action for Deprivation of Rights**.

59) **Judicial officers have no immunity when they have no jurisdiction over subject matter.**

60) This court shall take mandatory Judicial Notice of the adjudged decision of the Supreme Court of the United States of *Bradley v Fisher* 80 U.S. 335 (1871), 351,352 that officers of the court have no immunity when they have no jurisdiction over the subject-matter. And further in *Bradley v Fisher* on page 352 and 352 is as follows: "Where there is clearly no jurisdiction over the subject matter any authority exercised is a usurped

authority, and for the exercise of such authority, when the want of jurisdiction is known to the judge, no excuse is permissible." This evidence of *Bradley v Fisher* 80 U.S. 335 (1871).

61) Either subject-matter jurisdiction exists, or it doesn't. Subject-matter jurisdiction has been denied, it must be proved by the party claiming that the court has subject-matter jurisdiction as to all of the requisite elements of subject-matter jurisdiction

62) "The use of the highways for the purpose of travel and transportation is not a mere privilege, but a common and fundamental Right of which the public and the individual cannot be rightfully deprived." – *Chicago Motor Coach vs. Chicago*, 169 NE 22; *Ligare vs. Chicago*, 28 NE 934; *Boon vs. Clark*, 214 SSW 607; 25 Am. Jur. (1st) Highways Sect. 163.

63) "The right of a citizen (or others similarly situated) to travel upon the public highways and to transport his property thereon, by horse-drawn carriage, wagon, or automobile is not a mere privilege which may be permitted or prohibited at will, but a common right which he has under his right to life, liberty, and the pursuit of happiness." – *Slusher v. Safety Coac Transit Co.* 229 Ky 731, 17 SW2d 1012, affirmed by the Supreme Court in *Thompson v. Smith* 154 S.E. 579. (emphasis added)

64) "The right to Travel; The right to Mode of Conveyance; The Right to Locomotion are all absolute Rights, and the Police cannot make void the exercise of rights. *State v. Armstead*, 60 s. 778, 779, and 781"

65) "The right to Park or Travel is part of the Liberty of which the Natural Person and citizen cannot be deprived without "due process of Law" under the fifth Amendment of the United States Constitution. *Kent v. Dulles* 357 US 116, 125:"

66) "State Police Power extend only to immediate threats to public safety, health, welfare, etc., *Michigan v. Duke* 266 US, 476 LED. At 449:"

67) "Traveling in an automobile on the public roads was not a threat to the public safety or health and constituted no hazard to the public, and such traveler owed nothing more than "due care" (as regards to tort for negligence) to the public and the owner owed no other duty to the public (e.g. State), he / she and his / her auto, having equal rights to and on the roadways / highways as horse and wagons, etc.; this same right is still substantive rule, in that speeding, running stop signs, and traveling without license plates, or registration are not threat to the public safety, and thus, are not arrestable offenses. *Christy v. Elliot*, 216 I 131, 74 HE 1035, LRA NS 1905 – 1910: *California v. Farley* 98 CED Rpt/ 89, 20 CA 3rd 1032 (1971)"

68) "Where rights secured by the Constitution are involved, there can be no rule-making or legislation, which would abrogate them. *Maranda v. Arizona* 384 US 4336, 125:"

69) "The claim and exercise of Constitutional Rights cannot be converted into a crime. *Miller v. Kansas* 230 F 2nd 486, 489:"

70) "For crime to exist, there must be an injured party (*Corpus Delicti*) There can be no sanction or penalty imposed on one because of this Constitutional right. *Serer v. Cullen* 481 F. 945:"

71) "If any Tribunal (court) finds absence of proof of jurisdiction over a person and subject matter, the case must be dismissed. *Louisville v. Motley* 2111 US 149, 29S. CT. 42. "The Accuser Bears the Burden of Proof Beyond a Reasonable Doubt."

72) "In light of my status the complaint against me must be brought before an Article III court as per the rules governing the Treaty of Peace and Friendship of 1787."

Therefore in accord with the official oath of the officers of this court et al that all fraudulently presented improperly serviced instruments as per bill of exchange / suits / ticket / complaint numbers: 48-2026-MM-400368-A-O, 48-2023-MO-008341-A-O, and 48-2023-2023-MM-001930-A-O be immediately dismissed, discredited and expunged from the record, etc.

73) "Lack of Federal Jurisdiction can not be waived or overcome by agreement of parties". *Griffin v. Matthews*, 310 F supra 341, 342 (1969): "

74) "Want of Jurisdiction may not be cured by consent of parties"> *Industrial Addition Association v. C.I.R.*, 323 US 310, 313."

- 75) "In Supreme Court case *Murdock v. Penn.* 319 US 105
"No state shall convert a liberty into a privilege, license it, and attach a fee to it".
- 76) See also; *Shuttlesworth v. Birmingham* 373 US 26
"If the state converts a liberty into a privilege, the citizen can engage in the right with impunity."
- 77) "Petitioner asserts "Where rights secured by the Constitution are involved, there can be no rule making or legislation, which would abrogate them" *Miranda v. Arizona* 384 U.S. 436, 491.
- 78) "An unconstitutional statute has been held to confer no authority on, and to afford no protection to, an officer acting thereunder." Also, "Officers cannot be punished for refusing to obey unconstitutional statute." (CJS 16, sec. 101, p. 479) "Such laws are in legal contemplation, as inoperative as though they had never been passed or as if the enactment had never been written, and are regarded as invalid or void from the date of enactment, and not only from the date on which it is judicially declared unconstitutional. Such a law generally binds no one, confers no rights, affords No Protections, and imposes no duties, and compliance therewith is unnecessary." (CJS 16, p. 469).
- 79) "No one is bound to obey an unconstitutional law and no courts are bound to enforce it." – 16 Am Juris 2nd, Sec 177 late 2d, Sec 256.
- 80) "The State cannot diminish rights of the People." – *Hurtado v. California*, 110 U.S. 516
- 81) "The state is a people and not the created form of government." – *Texas v. White*, 7 Wallace, 700-74.
- 82) "The individual may stand upon constitutional rights. He is entitled to carry on his private business in his own way. His power to contract is unlimited. He owes no duty to the state or to his neighbors to divulge his business or to open his door to an investigation, so far as it may tend to incriminate him. He owes no such duty or the state, since he receives nothing therefrom, beyond the protection of his life and property. His rights are such as existed by the Law of the Land, long antecedent to the organization of the state... He owes nothing to the public so long as he does not trespass upon their rights." *Hale v. Henkel*, 201 U.S. 43 (1905).
- 83) "The makers of the Constitution conferred, as against the government, the Right to be let alone; the most comprehensive of rights, and the right most valued by civilized men." – United States Supreme Court Justice Brandeis in *Olmstead v. United States* (1928).
- 84) Based on customary international laws, the 5th Amendment of the Constitution for the United States of America, which guarantees due process of the law and Article IV of same Constitution Section 1; Full Faith and Credit shall be given in each State to the public Acts, Records and judicial proceedings of every other state...
- 85) No person shall be denied the enjoyment of any civil or military right, nor be discriminated against in the exercise of any civil or military right, nor be segregated in the militia or in the public schools, because of religious principles, race, color, ancestry or national origin...

1. **The Enforcement of the following:** The Divine Constitution and By-Laws of the Moorish Science Temple of America; The Moorish Nation of North America; Act VI: By Being Moorish American, you are Part and Parcel of this said government and Must Live the Life Accordingly; Article VI of the United States Constitution Republic / The Treaty of Peace and Friendship of EIGHTEEN HUNDRED and THIRTY-SIX (1836) A.D., Classifies Moorish Americans as Federal Citizens Possessing Freehold by Inheritance Status-Truth A-1. See Article 3, Section 2 of 'The Constitution for the United States of America'.

1) I, Ilhahi Ankaa Bey, demand Due Process as protected by the Fourth (4th) and Fifth (5th) Amendments of the Constitution for the United States of America (Republic).

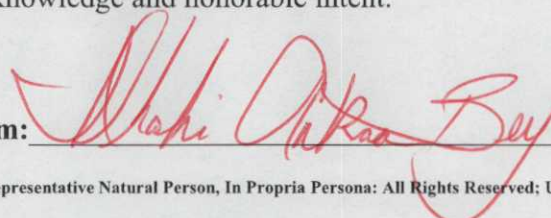
2) I, Ilhahi Ankaa Bey, demand this United States Supreme Court stop these abuses of the colorable authority by the Plaintiff as it pertains to this Claimant / Petitioner.

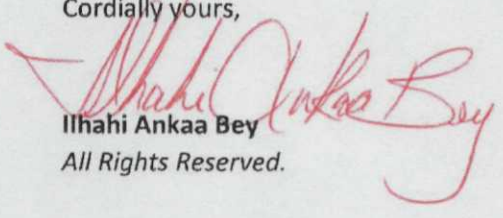

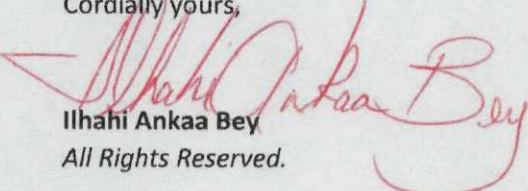

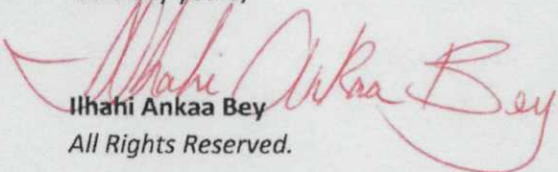
